BASIC PACKAGE & PACKAGE PRICES: Basic package includes air and ground transportation from Harrisburg to Snowmass, CO; 7 nights lodging at Stonebridge Inn in Snowmass; daily hot buffet breakfast; 5 of 7 day lift ticket to Aspen, Aspen Highlands, Buttermilk & Snowmass; free shuttle service to all mountains and town; welcome party; and farewell dinner. Basic package prices (all fees listed are per person): \$2,228.00 single occupancy; \$1,599.00 double occupancy; \$1,464.00 triple occupancy; \$1,396.00 quad occupancy. Discounted lift ticket prices are available for juniors and non skiers only. Juniors deduct \$93.00 and non-skiers deduct \$260.00. Sixth day lift ticket option is \$52.00.

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between Harrisburg & Denver, CO. Land-only prices (all fees listed are per person): \$1,743.00 single occupancy; \$1,114.00 double occupancy; \$979.00 triple occupancy; and \$ 911.00 quad occupancy.

Single trip participants signing up for double occupancy will not be guaranteed the double room rates if not applying with a roommate. The trip leader will do everything possible to find an acceptable roommate, however the single occupancy rate will be applied to the final payment if a roommate cannot be found. Cancellation fees will apply.

PAYMENT SCHEDULE (all fees listed are per person)

- \$500.00 initial deposit with application
- \$500.00 second installment by September 17, 2010
- Final payment, balance plus any extras requested by November 24, 2010

LATE PAYMENT FEE - \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on this application will be used for airline ticketing, must be legible, and must match your government-issued photo ID. If there is a discrepancy, minimum - \$150.00 fee. If you cancel after ticketing and find your own replacement, name change fees as stated above apply.

DEVIATIONS FROM ITINERARY - \$100.00 fee per change + Airline Charges

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. **CANCELLATION FEES (if replacement is not found) & SHIFT FEES** (all fees listed are per person) include:

- **Cancellation prior to September 17, 2010 - \$5 fee per trip day (e.g., the penalty for a day trip is \$5; the penalty for a 7-day trip is \$35)**
- Cancellation from September 17, 2010, through November 24, 2010 - \$150.00 fee
- NO REFUND for cancellation ON OR AFTER November 25, 2010.
- If you cancel after ticketing and find a replacement - \$150.00 to \$175.00 fee

DAMAGES: Individuals are responsible for any damages which they may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed.
- Applicant must be current SSC members.
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*.
