BASIC PACKAGE & PACKAGE PRICES: Basic package includes roundtrip air on Delta between Harrisburg & Salt Lake City, roundtrip mountain transfers, portorage, 7 nights lodging at Cliff Lodge & Spa, daily full buffet breakfasts, welcome party, farewell pizza party, and 6-day lift pass at Snowbird. **Basic package prices** (all fees listed are per person): \$2,451 single occupancy; \$1,785 double occupancy; \$1,565 triple occupancy; \$1,455 quad occupancy. Children under 12 stay and ski/ride free. Skiers can upgrade their lift pass to dual Snowbird/Alta 6-day pass for an additional \$100 (Alta does not permit snowboarding). Nonskiers subtract \$110 from the basic package price.

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between Harrisburg & Salt Lake City. **Land-only prices** (all fees listed are per person): \$1,904 single occupancy; \$1,238 double occupancy; \$1,018 triple occupancy; \$908 quad occupancy.

Single trip participants signing up for double occupancy will not be guaranteed the double room rates if not applying with a roommate. The trip leader will do everything possible to find an acceptable roommate, however the single occupancy rate will be applied to the final payment if a roommate cannot be found. Cancellation fees will apply.

PAYMENT SCHEDULE (all fees listed are per person)

- \$600 initial deposit with application
- \$600 second installment by September 1, 2010
- Final payment, balance plus any extras requested by November 2, 2010

LATE PAYMENT FEE - \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on this application will be used for airline ticketing, must be legible, and must match your government-issued photo ID. If there is a discrepancy, minimum name change fee is \$25.00.

DEVIATIONS FROM ITINERARY - \$100.00 fee per change + plus any additional charges as a result of the change if the change is possible

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. **CANCELLATION FEES (if replacement is not found) & SHIFT FEES** (all fees listed are per person) include:

- **Cancellation prior to September 8, 2010 – \$40 fee**
- Cancellation from September 8, 2010 through November 15, 2010 – \$140 fee
- Cancellation from November 16 through December 6, 2011 – \$290 fee
- NO REFUND for cancellation ON OR AFTER December 7, 2010.
- If you cancel after ticketing and find your own replacement – minimum \$190 fee to transfer ticket to a substitute passenger

DAMAGES: Individuals are responsible for any damages which they may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed.
- Applicant must be current SSC members.
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*.

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage. A suggested travel insurance company is TRAVELEX.
