BASIC PACKAGE & PACKAGE PRICES: Basic package includes roundtrip air BWI to Kamloops, B.C., bus transfers to airports and resort, 7 nights lodging at Delta Sun Peaks Resort, 6 full buffet breakfasts, 5 day lift pass, complimentary guided tours, all taxes. **Basic package prices** (all fees listed are per person and in US\$): \$2111 single occupancy; \$1626 double occupancy. Discounted lift ticket prices are available for Seniors (65+) and kids (13-18) – subtract \$55; kids 6-12 – subtract \$135. Non-skiers, subtract \$280 off package price.

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between BWI & KAMLOOPS airports. **Land-only prices** (all fees listed are per person and in US\$): \$1681 single occupancy; \$1196 double occupancy.

Single trip participants signing up for double occupancy will not be guaranteed the double room rates if not applying with a roommate. The trip leader will do everything possible to find an acceptable roommate, however the single occupancy rate will be applied to the final payment if a roommate cannot be found. Cancellation fees will apply.

PAYMENT SCHEDULE (all fees listed are per person):

- \$500 initial deposit with application
- Second installment, \$800 + any insurance deposit, by November 7, 2010
- Final payment, balance plus any extras requested by December 17, 2010.

LATE PAYMENT FEE - \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on this application will be used for airline ticketing, must be legible, and must match the name on your passport. If there is a discrepancy, minimum - \$175 fee within 31 days of departure. If you cancel after ticketing and find your own replacement, name change fees as stated above apply.

DEVIATIONS FROM ITINERARY – **Applicable fees** charged by hotel, airline, tour operator and/or insurance carrier. Minimum \$50 air deviation charge.

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. **CANCELLATION FEES (if replacement is not found) & SHIFT FEES** (all fees listed are per person) include:

- **Cancellation prior to 11/20/10 - \$40 fee**
- Cancellation from 11/20/10 through 1/27/11 - \$600 + cost of any trip insurance fees paid.
- NO REFUND for cancellation ON OR AFTER 1/28/11.
- If you cancel after ticketing and find a replacement more than 5 days prior to departure - \$175 fee.

DAMAGES: Individuals are responsible for any damages which they may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed.
- Applicant must be current SSC members.
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*.

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage.
