**BASIC PACKAGE & PACKAGE PRICES:** Basic package includes roundtrip motor coach transport between Harrisburg & resort, 5 nights lodging at the Marriott Residence Inn, hotel portorage, daily hot & cold breakfast buffet, afternoon snacks, 4 day lift pass, welcome party, on-mountain lunch, bus driver gratuities, and all taxes. **Basic package prices** (all fees listed are per person and in US\$): \$1,225 single occupancy; \$915 double occupancy; \$815 triple occupancy; \$760 quad occupancy. Discounted lift ticket prices are available for Seniors (Age 65+) and Youth (Age 7-17) deduct \$40. Non-skiers deduct \$160.

Single trip participants signing up for double occupancy will not be guaranteed the double room rates if not applying with a roommate. The trip leader will do everything possible to find an acceptable roommate, however the single occupancy rate will be applied to the final payment if a roommate cannot be found. Cancellation fees will apply.

**PAYMENT SCHEDULE** (all fees listed are per person)

- \$300 initial deposit with application
- \$300 second installment by November 1, 2010
- Final payment, balance plus any extras requested by December 16, 2010.

**LATE PAYMENT FEE** - \$20.00 on all payments seven (7) days past due

**NAME CHANGE FEES** – The name(s) printed on this application must be legible, and must match the name on your passport. Substitutions or name changes within 31 days of departure are subject to a \$50 charge per change. No changes will be allowed within 5 business days of departure.

**CANCELLATIONS** will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment.

**CANCELLATION FEES (if replacement is not found) & SHIFT FEES** (all fees listed are per person) include:

- **Cancellation prior to November 1, 2010 - \$50**
- Cancellation from November 1, 2010 through December 29, 2010 - \$350 fee plus any insurance premiums paid
- Cancellation from December 30, 2010 through January 21, 2011 - \$600 fee plus any insurance premiums paid
- NO REFUND for cancellation ON OR AFTER January 22, 2011.

**DAMAGES:** Individuals are responsible for any damages which they may cause to lodgings and resort facilities, equipment and provided transportation

**OTHER REQUIREMENTS:**
