

**SUSQUEHANNA SKI & SNOWBOARD CLUB  
ALASKAN CRUISE AND LAND TRIP TERMS  
FRIDAY AUGUST 28, 2020 TO THURSDAY SEPTEMBER 10, 2020**

*All prices and fees listed are per person.*

**BASIC PACKAGE & PACKAGE PRICES: Basic package includes:** All ground transportation, roundtrip air from Dulles, 2 nights lodging at the Opus Hotel in Vancouver, British Columbia, including welcome beverage, daily full breakfast and a \$75CAD per room food and beverage credit, 10- night Double Denali Northbound Alaska Cruise and Land Tour on the Holland America, Noordam (onboard credit of \$675 per cabin for verandah and \$650.00 per cabin for ocean view, dinner for 2 at Pinnacle Grill, all taxes and port fees and premium internet package with the Verandah Staterooms for bookings through October 8, 2019 and will be updated at that time.), 2 nights stay at McKinley Chalet Resort ( Denali Dollar gift card \$50 per person double occupancy, \$25 single occupancy plus an additional \$25.00 per person when staying in the upgraded room), Tundra Wilderness Tour in Denali National Park, ride on the McKinley Explorer domed rail car and one night stay in Anchorage. Ports include Ketchikan, Juneau, Skagway and Seward Alaska.

**Not Included:** Airline checked baggage fees are NOT included in the basic package price. The cruise automatically charges \$14.50 per person per day for gratuities which will be added to your account and charged to your credit card on the last day. Alcoholic beverages, soda and internet are not included on the cruise. Food and drinks are not covered on the land portion of the trip.

**Cabin Categories (you must choose one):**

We have three categories of cabins reserved to provide booking options for you to choose from (To see ship diagram for cabin space, check <https://www.hollandamerica.com>). Below pricing is only good until October 8, 2019 and pricing will be adjusted at that time.

- **Interior Stateroom (Category L)** – 2 lower beds convertible to 1 queen bed, shower, approximately 151 – 233 square feet. \$3,462.00
- **Oceanview Stateroom (Category F)** - 2 lower beds, convertible to 1 queen bed, bathtub & shower, approximately 174-180 square feet. \$3962.00
- **Verandah Staterooms (Category VD)** – 2 lower beds, convertible to 1 queen bed, bathtub & shower, sitting area, private verandah, floor to ceiling windows, approximately 212-359 square feet including verandah. \$4462.00

**LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes** all elements of basic package less the roundtrip airfare. For land only, you can deduct \$695.00 from the pricing above. For those making their own flight arrangements in order to use the group coach transfers, the flights must coordinate with those of the group.

**PAYMENT SCHEDULE**

- \$1000.00 initial deposit with application
- \$1000.00 second installment by February 1, 2020
- Final payment, balance plus any extras requested by April 30, 2020.

**LATE PAYMENT FEE:** \$20.00 on all payments seven (7) days past due

**CANCELLATIONS** will become valid upon confirmed receipt of a written notice to the trip leader from the participant or being removed by the trip leader for non-payment. There are no substitutions or name changes allowed so they will be considered a cancellation. Cancellation fees for the cruise include:

- Cancellation from time of booking up to June 25, 2020 - \$500 per person is non-refundable
- Cancellation from June 26, 2020 through July 18, 2020 – 50% non-refundable plus \$250.00
- Cancellation from July 19, 2020 through August 8, 2020- 75% non-refundable plus \$250.00
- NO REFUND for cancellation ON OR AFTER August 9, 2020

**Note: Holland America charges the fees outlined above. If the cancellation occurs before May 28, 2020, there can be an air refund, but the cruise penalty above will apply. If the cancellation occurs on or after May 29, 2020 the cost of the flight is not refundable.**

**NAME CHANGE FEES: Name changes or substitutions are not allowed by Holland America and will be considered a cancellation and shall be subject to the cancellation fees.** If a cancellation is made, the club will not be able to resell the stateroom. The name(s) printed on your trip application will be used for airline ticketing, must be legible, and must match your government-issued passport.

**PASSPORT:** Your passport must also be valid for six months following the last date of travel. For more information, go to <https://travel.state.gov/passport>. Please attach a copy of the passport for each participant to your application.

Please note that some persons will have difficulty gaining entry into Canada due to criminal records, including DWI and SUI charges. Anyone with a criminal record including DWI charges should contact the Canadian Consulate General before travel. **TRAVEL INSURANCE** is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage. Travel insurance can be purchased through Travelex Insurance through our tour operator as follows:

From ages 19-59 years, the cost is 7.1% of the trip cost and from ages 60 years and up, the cost is 9.9% of the trip cost. The insurance protects against trip cancellation for medical reasons, trip interruption insurance, baggage insurance, emergency medical expenses, accidental death & dismemberment and travel assistance services. The trip leader can obtain a customized quote for you.

**DAMAGES:** Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation

**OTHER REQUIREMENTS:**

- Reservations cannot be accepted unless deposit is made, and trip application and terms agreements are signed.
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
