All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes Roundtrip bus from Harrisburg to OKEMO, 4 nights' lodging (queen/queen) at the JACKSON GORE Hotel (ski in, ski out) and daily breakfast voucher. **Lift tickets are NOT included in this price** Basic package prices: \$1716 single occupancy; \$ 1062 double occupancy; \$ 832 triple occupancy; \$736 quad occupancy. Non skier, no deductions.

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip bus from Harrisburg to Okemo. **Land-only prices:** \$1448 single occupancy; \$794 double occupancy; \$564 triple occupancy; \$468 quad occupancy.

PAYMENT SCHEDULE

- \$350 initial deposit with application
- \$400 second installment by 11/23/21
- Final payment, balance plus any extras requested by 1/21/22

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to 10/1/21 up to \$164 fee**
- Cancellation from 10/2/21 through 12/1/21 - up to \$327 fee
- Cancellation from 12/2/21 through 1/27/22 - up to \$490 fee
- NO REFUND for cancellation ON OR AFTER 1/31/22

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, the participant should contact your trip leader prior to submitting the initial deposit and application to assure coverage. Due to recent events **travel insurance is highly recommended.**

DAMAGES: Individuals are responsible for any damages that participants may cause to lodgings and resort facilities, equipment and provided transportation

PUBLIC HEALTH ORDER: Group understands and agrees that the event must be conducted in accordance with all applicable public health orders and/or guidelines and resort operating procedures provided to Group by Resort, which may include, but are not limited to, physical distancing and face covering mandates. Guests may be required to wear face coverings in certain areas, including in indoor resort facilities, and whenever it is not possible to maintain a six feet distance from unknown parties. Guests are strongly encouraged to bring their own face coverings, but Resort will have them available upon request, subject to availability.
