Feb. 18 to 25, 2023

All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes: Roundtrip air from BWI to Denver, on Southwest Airlines; Roundtrip ground transportation – Denver to/from Snowmass; 7 nights lodging at The Stonebridge Inn; 7 full buffet breakfasts; 5 of 10 day ski pass (valid at Aspen, Snowmass, Aspen Highlands, and Buttermilk); Round trip baggage handling. Applicable airline checked baggage fees are NOT included in the basic package price. **Basic package prices:** \$3933 single occupancy; \$2763 double occupancy; Additional 6th day ticket is available for an additional \$95. *Seniors age 65+:* deduct \$30 for 5-day ticket but add \$85 for 6th day ticket; *Seniors age 80+:* deduct \$390; *Non skiers:* deduct \$390

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between BWI & Denver Airport. Ground transfer is NOT guaranteed if individuals arrive at different times after the main group (scheduled or actual). **Land-only prices:** \$3528 single occupancy; \$2358 double occupancy

PAYMENT SCHEDULE

- \$700 initial deposit with application
- \$700 second installment by 9/26/22
- \$700 second installment by 11/1/22
- Final payment, balance plus any extras requested by 12/12/22

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, **must be legible, and must match your government-issued photo ID that is in compliance with the ‘REAL ID Act of 2005’.** If the information provided on participant application is incorrect, the participant is responsible for the airline name change fee. The minimum airline name change fee is \$200.

SHIFT FEES: If you cancel after ticketing and find your own replacement, \$200 fee. Name change fees as stated above will also apply.

DEVIATIONS FROM ITINERARY: \$200 fee per change + Airline Charges

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant’s responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to 9/25/22 - \$210**
- Cancellation from 9/26/22 through 10/26/22 - \$508 fee
- Cancellation from 10/27/22 through 12/31/22- \$995 fee
- NO REFUND for cancellation ON OR AFTER 1/1/23

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, the participant should contact your trip leader prior to submitting the initial deposit and application to assure coverage. Due to recent events **travel insurance is highly recommended.**

DAMAGES: Individuals are responsible for any damages that participants may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless trip deposit is made.
- By signing the Aspen/Snowmass Trip application, you acknowledge these trip terms.
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
