

**SUSQUEHANNA SKI & SNOWBOARD CLUB
BRECKENRIDGE TRIP TERMS
January 27 – February 3, 2018**

All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: **Basic package includes:** Trip package pp/dbl./occ. includes: 7 nights lodging at The DoubleTree by Hilton Hotel with two queens beds, daily breakfast, roundtrip air between Harrisburg and Denver via Chicago, roundtrip ground transfers, baggage handling at the DoubleTree, and 5-day lift ticket at Breckenridge (accepted at Arapahoe Basin, Keystone, Vail, and Beaver Creek). The winter carnival full activity package includes a welcome reception, kick-off breakfast, on mountain poker run, mid-week lunch, après party, themed gala with dinner and entertainment, group race training and competition, awards ceremony and dessert reception. Airline checked baggage fees are NOT included in the basic package price.

Basic package prices: \$3,109 single occupancy; \$2,150 double occupancy. Discounted lift ticket prices are available for Seniors age 65+ (deduct \$46); Child (5-12 years) deduct \$152. Prepaid Senior upgrade to 6th day additional \$20. Non skiers and EPIC pass holders, deduct \$368. Single supplement rate additional \$959. Land only deduct \$452. King size bed deduct \$92 per person.

LAND-ONLY PACKAGE & PACKAGE PRICES: **Land-only package includes** all elements of basic package less the roundtrip airfare between Harrisburg & Denver. **Land-only prices:** \$2,657 single occupancy; \$1,698 double occupancy.

PAYMENT SCHEDULE

- \$600 initial deposit with application
- \$550 second installment by August 15, 2017
- \$550 third installment by October 3, 2017
- Final payment, balance plus any extras requested by December 1, 2017

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, must be legible, and must be legible, and must match your government-issued photo ID that is in compliance with the "REAL ID Act of 2005". If there is a discrepancy, minimum name change fee is \$100.

SHIFT FEES: If you cancel after ticketing and find your own replacement, applicable fees at the time will apply. Name change fees as stated above will also apply.

DEVIATIONS FROM ITINERARY: \$100 fee per change + Airline Charges

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to September 29, 2017 - \$40**
- **Cancellation from September 29, 2017 through November 27, 2017 - \$150 fee**
- **Cancellation from November 28, 2017 through December 11, 2017 - \$250 fee**
- **NO REFUND for cancellation ON OR AFTER December 12, 2017**

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage.

DAMAGES: Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
