### Banff / Lake Louise 2022 TRIP TERMS

Dates: February 19 – 26, 2022

*All prices and fees listed are per person.*

**BASIC PACKAGE & PACKAGE PRICES:** Basic package includes Roundtrip bus to Newark airport, Roundtrip airfare on Air Canada (Newark to Calgary), Roundtrip transfers Calgary to Banff, seven nights lodging @ Moose Hotel & Suites, baggage handling, daily hot breakfast, five of eight-day interchangeable lift tickets valid at Mt. Norquay, Banff Sunshine, and Lake Louise. Airline checked baggage fees are NOT included in the basic package price. **Basic package prices:** \$2,465 single occupancy; \$1,915 double occupancy; \$1,775 triple occupancy; \$1,695 quad occupancy. Deduct \$300.00 for non-skiers. Deduct \$60.00 for Seniors 65+ with a five-day lift ticket. Add \$60.00 to upgrade to six-day lift ticket. Add \$ 48.00 for Seniors 65+ with a six-day lift ticket.

**LAND-ONLY PACKAGE & PACKAGE PRICES:** Land-only package includes all elements of basic package less the roundtrip airfare between Newark, NJ & Calgary Alberta, Canada. **Land-only prices:** \$2,015 single occupancy; \$1,465 double occupancy; \$1,325 triple occupancy; \$1,245 quad occupancy.

#### PAYMENT SCHEDULE

- \$650.00 initial deposit with application
- \$650.00 second installment by 09/07/21
- Final payment, balance plus any extras requested by 11/02/21

**LATE PAYMENT FEE:** \$20.00 on all payments seven (7) days past due

**NAME CHANGE FEES:** The name(s) printed on your trip application will be used for airline ticketing, **must be legible, and must match your government-issued photo ID that is in compliance with the 'REAL ID Act of 2005'**. If the information provided on participant application is incorrect, the participant is responsible for the airline name change fee. The minimum airline name change fee is \$100.00.

**SHIFT FEES:** If you cancel after ticketing and find your own replacement, \$100 to \$350 fee. Name change fees as stated above will also apply.

**DEVIATIONS FROM ITINERARY:** 100.00 fee per change + Airline Charges

**CANCELLATIONS** will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to 10/15/21** - \$130
- Cancellation from 10/16/21 through 11/09/21 - \$295 fee
- Cancellation from 11/10/21 through 12/09/21 - \$595 fee
- NO REFUND for cancellation ON OR AFTER 12/10/21

**TRAVEL INSURANCE IS HIGHLY RECOMMENDED** for all trip participants, especially in light of unforeseen events. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition most insurance companies require you to obtain insurance within two weeks from the date you made your trip deposit (this may vary among insurance companies).

**DAMAGES:** Individuals are responsible for any damages that participants may cause to lodgings and resort facilities, equipment and provided transportation

#### OTHER REQUIREMENTS:

- Reservations cannot be accepted unless trip deposit is made.
- Signed Banff / Lake Louise 2022 Trip application acknowledges these trip terms.
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
