SSC CANCUN 2022 TRIP TERMS Dec. 4-11, 2022**

All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: **Basic package includes** All ground transportation, roundtrip air from BWI to Cancun International Airport, 7 nights lodging at Club Med Cancun, superior rooms with furnished balconies and view of lagoon or gardens, all meals and snacks, unlimited premium alcoholic and non-alcoholic beverages, tips, taxes, gratuities, daily live entertainment and non-refundable Club Med Membership. Airline checked baggage fees are NOT included in the basic package price. **Basic package prices:** \$1890 double occupancy; single occupancy considered upon request, no price guarantee; triple and quad limited to children 16 and under. Any on-site activities or excursions that require a reservation or additional payment are made at the discretion of the participants. No group activities are planned. Since air pricing is not yet available, we have estimated the cost to be \$500. Once actual price is known, we will adjust the pricing

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between BWI & Cancun. Land-only prices: \$TBD - single occupancy; \$1390.00 - double occupancy;

PAYMENT SCHEDULE: (Make checks payable to: “Susquehanna Ski Club”).

- \$600 initial deposit with application. Please also include copy of your passport.
- \$600 second installment by July 20, 2022
- Final payment, balance due September 10, 2022

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, must be printed, legible, and must MATCH EXACTLY NAME ON PASSPORT. If the information provided on participant application is incorrect, the participant is responsible for the airline name change fee. The minimum airline name change fee is \$ _____. Name change and/or addition to Club Med room list after October 19, 2022 will incur a \$30 name change fee.

SHIFT FEES AND DEVIATIONS FROM ITINERARY: If you cancel after ticketing and find your own replacement, \$ _____ to \$ _____ fee. Name change fees as stated above will also apply. \$ _____ fee per change + Airline Charges. *Airline fees and charges for changes will be determined after our airline reservations are confirmed in mid-January, 2022*

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant’s responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to July 10, 2022 - \$35**
- Cancellation from August 7, 2022 through September 4, 2022 - up to \$500.00 per room per night fee.
- Cancellation from September 5, 2020 through September 19, 2020 – up to \$500.00 per room per night fee.
- NO REFUND for cancellation ON OR AFTER September 20, 2022

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, the participant should contact your trip leader prior to submitting the initial deposit and application to assure coverage. Due to recent events **travel insurance is highly recommended.** Your Club Med membership includes a Basic Travel Protection Plan. DAMAGES: Individuals are responsible for any damages that participants may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless trip deposit is made. Signed SSC CANCUN 2022 Trip application acknowledges these trip terms. Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
- A valid credit card swipe is required at check in.
