

**SUSQUEHANNA SKI & SNOWBOARD CLUB
COPPER MOUNTAIN, COLORADO TRIP TERMS
JANUARY 7 – 14, 2024 (SUNDAY TO SUNDAY)**

All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes: Roundtrip air from BWI to Denver, on United Airlines. Roundtrip ground transportation – Harrisburg/BWI and Denver/Copper; 7 nights lodging at the Element 29 Hotel; 5- day ski pass; Round trip baggage handling. Airline checked baggage fees are NOT included in the basic package price. **Basic package prices:** \$3,182 single occupancy; \$2362 double occupancy; \$2,211 triple occupancy; \$2,138 quad occupancy. There are no discounted tickets for senior skiers/snowboarders. *Non skiers/snowboarders* – deduct \$340. *If you do not need a lift ticket because you have an Ikon Pass and/or a Copper Pass* – deduct \$340. **NOTE: Pricing is based on 22 people. Should the group fall below this level, the price may have to be re-calculated.**

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between BWI & Denver. **Land-only prices:** \$2,752 single occupancy; \$1,932 double occupancy; \$1,781 triple occupancy; \$1,780 quad occupancy.

PAYMENT SCHEDULE (Payable to SSC)

- \$700 initial deposit with application
- \$700 second installment by September 30, 2023
- Final payment, balance plus any extras requested by November 14, 2023

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, **must be legible, and must match your government-issued photo ID that is in compliance with the ‘REAL ID Act of 2005’.** If the information provided on participant application is incorrect, the participant is responsible for the airline name change fee. The minimum airline name change fee is \$200 for Name Changes after November 23, 2023 but prior to December 28, 2023. No name changes after December 29th.

SHIFT FEES: If you cancel after ticketing and find your own replacement, \$200 fee. Name change fees as stated above will also apply.

DEVIATIONS FROM ITINERARY: \$200 fee per change + Airline Charges

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant’s responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to 9/3/2023 –up to \$130**
- Cancellation from 9/4/2023 through 11/2/2023 –**up to \$964 fee**
- Cancellation from 11/3/2023 through 11/20/2023 – **up to \$1782 fee**
- **NO REFUND for cancellation ON OR AFTER 11/21/2023**

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, the participant should contact your trip leader prior to submitting the initial deposit and application to assure coverage. Due to recent events **travel insurance is highly recommended.**

DAMAGES: Individuals are responsible for any damages that participants may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless trip deposit is made.
- By signing the Copper Mountain 2024 Trip application, you acknowledge these trip terms.
- Applicant must be a current SSC member or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
