All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes: Roundtrip bus to Dulles, Roundtrip air, 12 nights lodging- 3 nights at each destination, daily breakfast, dinner first night with wine Greek music and dancing, 4 tours – one at each location, portage at Mykonos, all ground transfers, and high speed ferry transfers. Hotel Center Square Athens***; Hotel Alkistis*** in Agios Stefanos, Mykonos; Hotel Horizon Resort*** at Santorini (some will be at Hotel Sunshine***); and Hotel Arkadia at Chania, Crete.

Airline checked baggage fees are NOT included in the basic package price. Excess fees are incurred over 50 lbs.

BASIC PACKAGE PRICE: \$3,100 double occupancy; single supplement \$625 and must be preapproved by tour operator. Optional tour to Delphi add \$53.

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between departure airport & destination airport. **Land-only prices:** \$2,100 double occupancy;

PAYMENT SCHEDULE

- \$775 initial deposit with application
- \$775 second installment by December 20, 2018
- \$775 third installment by February 20, 2019
- Final payment, balance plus any extras requested by May 20, 2019

OPTIONAL MONTHLY PAYMENT PLAN available upon request.

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due.

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, must be printed, legible, and must match your PASSPORT. If there is a discrepancy, minimum name change fee is \$300. No changes permitted to an itinerary or name once tickets have been issued. Name changes in event of a death of immediate family member, at tour operator discretion, minimum \$300 fee.

DEVIATIONS FROM ITINERARY: Must be made in writing, prior to ticketing and require a \$200 fee + Airline Charges

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to November 15, 2018 - \$70**
- Cancellation from November 15, 2018 through June 1, 2019 - \$200
- Cancellation from June 2, 2019 through July 31, 2019 - \$400
- NO REFUND for cancellation ON OR AFTER August 1, 2019

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage.

DAMAGES: Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand in Loco Parentis Form*
