NEW YORK WINE TOUR TRIP TERMS  
OCTOBER 27 – 29, 2017**

*All prices and fees listed are per person.*

**BASIC PACKAGE & PACKAGE PRICES:** Basic package includes roundtrip transportation on Elite Coach from Harrisburg area, two nights lodging at the Radisson Hotel, Corning, NY, wineries tasting fees, lunch at Glenora Wine Cellars, and Dinner at Belhurst Castle. Baggage fees are NOT included in the basic package price.

**Basic package prices:** \$375.00 double occupancy; Call for other rates.

**PAYMENT SCHEDULE**

- \$200.00 initial deposit with application
- Final payment, \$175.00 by August 28, 2017

**LATE PAYMENT FEE:** \$20.00 on all payments seven (7) days past due.

**DEVIATION:** Some wineries have what are called flights. When flights are available one flight is Sweet and the other is Dry. You will have your choice which one you want. If you want both, the winery will give you an extra charge, each flight is 4 to 6 tastings.

**CANCELLATIONS** will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation after September 1, 2017 and before September 25, 2017 - \$150.00 fee will be retained by the trip if we can't fill your spot.**
- **NO REFUND for cancellation ON OR AFTER September 25, 2017 if you cannot fill your spot.**

**TRAVEL INSURANCE** is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage.

**DAMAGES:** Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation

**OTHER REQUIREMENTS:**

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand in Loco Parentis Form*
