

**SUSQUEHANNA SKI & SNOWBOARD CLUB  
NATIONAL PARK TOURS 2021 TRIP TERMS  
September 18, 2021- September 28, 2021**

*All prices and fees listed are per person.*

**BASIC PACKAGE & PACKAGE PRICES:** **Basic package includes** All ground transportation, roundtrip air (airline and airport to be determined). Two nights lodging in Las Vegas at the Treasure Island (first and last night), 1 night lodging Kachina Lodge in Grand Canyon National Park, 2 nights lodging Lake Powell Resort, 1 night lodging Goulding's Lodge Monument Valley, 2 nights lodging Red Cliffs Lodge Moab, 2 nights lodging Best Western Plus Bryce Canyon Bryce Canyon National Park, all park entrance fees (Grand Canyon, Monument Valley, Moab, Arches National Park, Canyonland National Park, Dead Horse Point State Park, Capital Reef National Park, Bryce Canyon National Park, and Zion National Park), 10 breakfasts, 5 three-course dinners, extras (cruise on Lake Powell, Navajo guide into red rock back country, 4 wheel-drive vehicle tour Monument Valley, wine tasting Moab), sightseeing, gratuities for bus driver, tour guide and all local guides in included excursions and services of a professional tour guide. Since air pricing is not yet available, we have estimated the cost to be \$500 and once the actual price is known, we will adjust the pricing. **Not included:** Airline checked baggage fees are NOT included in the basic package price. **Basic package prices:** \$4938 single occupancy; \$3795 double occupancy; \$3556 triple occupancy.

**LAND-ONLY PACKAGE & PACKAGE PRICES:** **Land-only package includes** all elements of basic package less the roundtrip airfare which is currently unknown. For land only at this time, you can deduct \$500 from the pricing above.

**PAYMENT SCHEDULE**

- \$1000 initial deposit with signed application
- \$1000 second installment by 2/2/2021
- \$1000 third installment by 5/1/2021
- Final payment, balance plus any extras requested by 7/1/2021

**LATE PAYMENT FEE:** \$20.00 on all payments seven (7) days past due

**NAME CHANGE FEES:** The name(s) printed on your trip application will be used for airline ticketing, **must be legible, and must match your government-issued photo ID that is in compliance with the 'REAL ID Act of 2005'**. If the information provided on participant application is incorrect, the participant is responsible for the airline name change fee. The minimum airline name change fee will be \$300

**SHIFT FEES:** If you cancel after ticketing and find your own replacement, Not known till airline chosen. Name change fees as stated above will also apply.

**DEVIATIONS FROM ITINERARY:** No deviation from itinerary are permitted by the company.

**CANCELLATIONS** will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to 4/21/21 - \$55**
- Cancellation from 4/22/21 through 7/7/21 - \$605 fee
- Cancellation from 7/8/21 through 8/18/21- \$813 double (20%) fee per application type + airfare
- Cancellation from 8/19/21 through 9/1/21- \$1192 double (30%) fee per application type + airfare
- Cancellation from 9/2/21 through 9/9/21- \$1952 double (50%) fee per application type + airfare
- NO REFUND for cancellation ON OR AFTER 9/10/21

**TRAVEL INSURANCE IS HIGHLY RECOMMENDED** for all trip participants, especially in light of unforeseen events. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition most insurance companies require you to obtain insurance within two weeks from the date you made your trip deposit (this may vary among insurance companies).

**DAMAGES:** Individuals are responsible for any damages that participants may cause to lodgings and resort facilities, equipment and provided transportation

**OTHER REQUIREMENTS:**

- Reservations cannot be accepted unless trip deposit is made.
- Signed National Parks Tour Trip application acknowledges these trip terms.
- Applicant must be current SSC members or must have applied for membership
