SNOWBIRD TRIP TERMS
FEBRUARY 10-17, 2018**

ALL PRICES AND FEES LISTED ARE PER PERSON.

BASIC PACKAGE & PACKAGE PRICES: **Basic package includes** roundtrip air from Harrisburg to Salt Lake City, Utah, ground transfers in Salt Lake City, 7 nights lodging at The Cliff Lodge at Snowbird, welcome reception, daily breakfast buffet, and 6- day lift ticket for Snowbird. Airline checked baggage fees are NOT included in the basic package price.

Basic package prices: \$2,538.00 single occupancy; \$1,818.00 double occupancy.

LAND-ONLY PACKAGE & PACKAGE PRICES: **Land-only package includes** all elements of basic package less the roundtrip airfare between Harrisburg & Salt Lake City. **Land-only prices:** \$2,090 single occupancy; \$1,370 double occupancy.

PAYMENT SCHEDULE

- \$500 initial deposit with application
- \$800 second installment by November 1, 2017
- Final payment, balance plus any extras requested by January 1, 2018

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: **The name(s) printed on your trip application will be used for airline ticketing, must be legible, must be legible, and must match your government-issued photo ID that is in compliance with the “REAL ID Act of 2005”.** If there is a discrepancy, minimum name change fee is \$175 from Jan. 3, 2018 until January 29, 2018, afterward cost is \$225.

SHIFT FEES: If you cancel after ticketing and find your own replacement, name change fees as stated above will apply.

DEVIATIONS FROM ITINERARY: Once ticketed up to \$225 fee per change + change in fare until January 30, 2018.

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to September 2, 2017 - \$40 fee**
- **Cancellation from September 2, 2017 through November 17, 2017 - \$100 fee**
- **Cancellation from November 18, 2017 through December 21, 2017 - \$300 fee**
- **NO REFUND for cancellation ON OR AFTER December 22, 2017**

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage.

DAMAGES: Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
