**TRIP TERMS: SÖLDEN, AUSTRIA 7 Nights + MAJORCA 4-Night Extension**  
**MARCH 4 – 12, 2022 and March 12 - 16, 2022**  
*All prices and fees listed are per person.*

**BASIC PACKAGE & PACKAGE PRICES: Basic package includes:** Roundtrip motorcoach transfer Harrisburg/Newark, roundtrip non-stop air EWR-ZRH, and MUN-EWR motorcoach transfers between hotels/airports, 7 nights lodging, Hotel Tyrolerhof\*\*\*\* Ambiente rooms, full European breakfast daily, 4-course dinner nightly, welcome reception, 5 of 7-day Ötztal Superskipass for Sölden, Obergurgl-Hochgurgl, Hochötz-Kühtai, Vent, Niederthai, and Gries, baggage tags and travel packets. Ambiente room with balcony +\$60. Both room types are limited.

**BASIC PACKAGE PRICE: \$2,845 double occupancy**

Non-skiers deduct \$360; Add 6<sup>th</sup> day +\$50; 4-Day deduct \$75; Seniors 80+ deduct \$160; Ambiente room with balcony add \$60; 4 Night Extension-Majorca: add estimated \$575;

**LAND-ONLY PACKAGE & PACKAGE PRICE: Land-only package includes** all elements of basic package less the roundtrip airfare between departure airport & destination airport. **Land-only: \$1,945 double occupancy.**

**PAYMENT SCHEDULE**

- \$775 initial deposit with application
- \$775 second installment by **August 15, 2021**
- \$775 third installment by **October 15, 2021**
- Final payment, balance plus any extras requested by **December 20, 2021**

**LATE PAYMENT FEE: \$20** on all payments seven (7) days past due.

**NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, must be printed, legible, and must MATCH EXACTLY NAME ON PASSPORT.** Any changes minimum fee is \$100. To transfer airline ticket to a substitute passenger fee is \$300.

**DEVIATIONS FROM ITINERARY:** Deviations require a minimum fee of \$150.

**CANCELLATIONS** will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

**SOLDEN**

- Cancellation prior to November 30, 2021 - \$65 fee
- Cancellation from December 1, 2021 through December 28, 2021 - \$800
- NO REFUND for cancellation ON OR AFTER December 29, 2021

**MAJORCA**

- Cancellation Prior to November 10, 2021 - \$200
- Cancellation November 10, 2021 to January 10, 2022 - \$450
- NO REFUNDS for cancellation ON OR AFTER January 10, 2022

**TRAVEL INSURANCE IS HIGHLY RECOMMENDED** for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, most insurance companies require you to obtain insurance within two weeks from the date you made your trip deposit. Group coverage is also available through the tour operator for this trip where age is not a factor in price.

**DAMAGES:** Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation
