STEAMBOAT SPRINGS TRIP TERMS  
JANUARY 22, 2022 - JANUARY 29, 2022**

*All prices and fees listed are per person.*

**BASIC PACKAGE & PACKAGE PRICES:** **Basic package includes** all ground transportation, roundtrip air from Baltimore to Hayden, 7 nights lodging at Ptarmigan Inn, daily hot breakfast, group portage, 5-day lift ticket. Airline checked baggage fees are NOT included in the basic package price. **Basic package prices:** \$3,100.00 single occupancy; \$2,200.00 double occupancy. Non-skier or Ikon pass holder with pass valid at Steamboat, deduct \$400.00, four-day lift ticket deduct \$80.00. Six-day lift ticket, add \$80.00. There are no further discounts available on lift tickets.

**LAND-ONLY PACKAGE & PACKAGE PRICES:** **Land-only package includes** all elements of basic package less the roundtrip airfare between Baltimore, MD & Hayden, CO. **Land-only prices:** \$2,650.00 single occupancy; \$1,750.00 double occupancy.

**PAYMENT SCHEDULE**

- \$700.00 initial deposit with application
- \$700.00 second installment by September 7, 2021
- Final payment, balance plus any extras requested by November 2, 2021

**LATE PAYMENT FEE:** \$20.00 on all payments seven (7) days past due.

**NAME CHANGE FEES:** The name(s) printed on your trip application will be used for airline ticketing, **must be legible, and must match your government-issued photo ID that is in compliance with the 'REAL ID Act of 2005'**. If the information provided on participant application is incorrect, the participant is responsible for the airline name change fee. The minimum airline name change fee is \$100.00.

**SHIFT FEES:** If you cancel after ticketing and find your own replacement, \$250.00 fee. Name change fees as stated above will also apply.

**DEVIATIONS FROM ITINERARY:** \$100.00 fee per change + any additional airline charges. Those traveling from other gateways will only need to pay the difference in airfare from their departure city based on availability – these people are not subject to the \$100.00 deviation fee.

**CANCELLATIONS** will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Participants who cancel once airfare is ticketed will have a non-refundable ticket. Cancellation fees include:

- **Cancellation prior to September 22, 2021 - \$130.00 fee**
- Cancellation from September 22, 2021 through October 20, 2021 - \$295.00 fee
- Cancellation from October 20, 2021 through November 19, 2021 - \$595.00 fee
- NO REFUND for cancellation ON OR AFTER November 19, 2021

**TRAVEL INSURANCE** is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, the participant should contact your trip leader prior to submitting the initial deposit and application to assure coverage. Due to recent events **travel insurance is highly recommended**.

**DAMAGES:** Individuals are responsible for any damages that participants may cause to lodgings and resort facilities, equipment and provided transportation

**OTHER REQUIREMENTS:**

- Reservations cannot be accepted unless trip deposit is made.
- Signed Steamboat Springs Trip application acknowledges these trip terms.
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
