

**SUSQUEHANNA SKI & SNOWBOARD CLUB
TAOS TRIP TERMS
MARCH 3-10, 2018**

All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes roundtrip air from Harrisburg to Albuquerque, all ground transfer to Taos, 7 nights lodging, 5 of 6 day lift ticket, group portorage, a welcome reception and a general manager hosted group dinner. Airline checked baggage fees are NOT included in the basic package price.

Basic package prices: \$2,298 single occupancy; \$1,838 double occupancy; A 6th-day lift ticket is available for an additional \$64. Senior (>65) lift ticket: deduct \$20; senior 6th day lift ticket: add \$60. Non skiers: deduct \$300.

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between Harrisburg & Albuquerque; ground transfer is NOT guaranteed if individuals arrive at different times after the main group (scheduled or actual). **Land-only prices:** \$1,260 double occupancy; \$1,720 single occupancy.

PAYMENT SCHEDULE

- \$600 initial deposit with application
- \$600 second installment by September 30, 2017
- Final payment, balance plus any extras requested by December 20, 2017

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, must be legible, and must match your government-issued photo ID that is in compliance with the "REAL ID Act of 2005". If there is a discrepancy minimum name change fee is \$175 from January 24, 2018 up to February 20, 2018. After this date change fee cost is \$225.

SHIFT FEES: If you cancel after ticketing and find your own replacement, name change fees as stated above will apply.

DEVIATIONS FROM ITINERARY: Up to \$225 fee per change + Airline Charges

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to September 2, 2017 - \$40 fee**
- **Cancellation from September 2, 2017 through November 29, 2017 - \$100 fee**
- **Cancellation from November 30, 2017 through December 20, 2017 - \$300 fee**
- **NO REFUND for cancellation ON OR AFTER December 21, 2017**

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage.

DAMAGES: Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
