BASIC PACKAGE & PACKAGE PRICES: Basic package includes All ground transportation, air travel from Newark to Vancouver and from Anchorage to Newark on Alaska Air, 2 nights lodging at the Opus Hotel in Vancouver ,British Columbia, including welcome beverage, daily full breakfast and a \$100 CAD per room food and beverage credit, 11- night Triple Denali Northbound Alaska Cruise and Land Tour on the Holland America, Nieuw Amsterdam, 3 nights stay at McKinley Chalet Resort, Tundra Wilderness Tour in Denali National Park, ride on the McKinley Explorer domed rail car and one night stay in Anchorage. Ports include Ketchikan, Juneau, Skagway and Whittier, Alaska. Cruise accommodation includes all meals onboard, entertainment and a full activities program. Ground transportation in Vancouver and Anchorage are included as well as all taxes and port fees included. If you book a Verandah Category VC or higher, the Have It All Package is included at no additional cost. Details of this package are on the Holland America Website, but include a credit of \$100 for excursions, signature drink package and WiFi Surf Package.

Not Included: Airline checked baggage fees are NOT included in the basic package price. The cruise automatically charges gratuities which will be added to your account and charged to your credit card on the last day of the cruise. Current charges for Veranda stateroom or lower is \$16.00 per cabin per night and \$17.50 per cabin per night for suites. Alcoholic beverages, soda and internet are not included on the cruise. Food and drinks are not covered on the land portion of the trip. Gratuities on the land portion of the trip are not included

NAME CHANGE FEES: Name changes or substitutions are not allowed by Holland America and will be considered a cancellation and shall be subject to the cancellation fees. If a cancellation is made, the club will not be able to resell the stateroom. The name(s) printed on your trip application will be used for airline ticketing, <u>must be legible</u>, and <u>must match your government-issued passport</u>.

CANCELLATIONS will become valid upon <u>confirmed receipt</u> of a written notice to the trip leader from the participant or being removed by the trip leader for non-payment. There are no substitutions or name changes allowed so they will be considered a cancellation. Cancellation fees for the cruise include:

- Cancellation from time of booking up to April 26, 2023 \$755 per person is non-refundable
- Cancellation from April 27, 2023 through June 21, 2023 \$1420.00 per person is non-refundable
- Cancellation from June 22, 2023 through July 14, 2023-80% of package price is non-refundable
- NO REFUND for cancellation ON OR AFTER July 15, 2023

PASSPORT: Your passport must also be valid for six months following the last date of travel. For more information, go to https://travel.state.gov/passport. Please attach a copy of the passport for each participant to your application.

Please note that some persons will have difficultly gaining entry into Canada due to criminal records, including DWI and SUI charges. Anyone with a criminal record including DWI charges should contact the Canadian Consulate General before travel. (www.geo.international.gc.ca/can-am/washington/offices/.defalt-en-asp.)

COVID 19 REQUIREMENTS: Currently, those travelling with a US Passport to Canada do not have to show proof of vaccination or a negative test. Holland American Line also does not currently have restrictions in place, but they will be updating their Covid protocol prior to the 2023 Alaska cruising season and once available, trip terms will be updated. Requirements will be updated regularly so passengers can check on the latest travel requirements.

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, the participant should contact your trip leader prior to submitting the initial deposit and application to assure coverage. Due to recent events travel insurance is highly recommended. We also recommend that your policy contain the SINGLE OCCUPANCY BENEFIT.
