Banff / Lake Louise 2021 TRIP TERMS

All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes Roundtrip bus to Newark airport, Roundtrip airfare on Air Canada (Newark to Calgary), Roundtrip transfers Calgary to Banff, seven nights lodging @ Moose Hotel & Suites, baggage handling, daily hot breakfast, five of eight-day interchangeable lift tickets valid at Mt. Norquay, Banff Sunshine, and Lake Louise. Airline checked baggage fees are NOT included in the basic package price. **Basic package prices:** \$2,405 single occupancy; \$1,855 double occupancy; \$1715 triple occupancy; \$1635 quad occupancy. Deduct \$300.00 for non-skiers. Deduct \$60.00 for Seniors 65+ with a five-day lift ticket. Add \$60 to upgrade to six-day lift ticket. Add \$48 for Seniors 65+ with a six-day lift ticket.

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between Newark, NJ & Calgary Alberta, Canada. **Land-only prices:** \$1,955 single occupancy; \$1,405 double occupancy; \$1265 triple occupancy; \$1185 quad occupancy.

PAYMENT SCHEDULE

- \$650.00 initial deposit with application
- \$650.00 second installment by 09/04/20
- Final payment, balance plus any extras requested by 11/06/20

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, **must be legible, and must match your government-issued photo ID that is in compliance with the 'REAL ID Act of 2005'**. If the information provided on participant application is incorrect, the participant is responsible for the airline name change fee. The minimum airline name change fee is \$100.00.

SHIFT FEES: If you cancel after ticketing and find your own replacement, \$100 to \$350 fee. Name change fees as stated above will also apply.

DEVIATIONS FROM ITINERARY: 100.00 fee per change + Airline Charges

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to 10/16/20** - \$130
- Cancellation from 10/17/20 through 11/10/20 - \$295 fee
- Cancellation from 11/11/20 through 12/10/20 - \$595 fee
- NO REFUND for cancellation ON OR AFTER 12/11/20

TRAVEL INSURANCE IS HIGHLY RECOMMENDED for all trip participants, especially in light of unforeseen events. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition most insurance companies require you to obtain insurance within two weeks from the date you made your trip deposit (this may vary among insurance companies).

DAMAGES: Individuals are responsible for any damages that participants may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless trip deposit is made.
- Signed Banff / Lake Louise 2021 Trip application acknowledges these trip terms.
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
