All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes: Roundtrip motorcoach transfers between Harrisburg/Newark. Roundtrip non-stop air EWR-ZRH, deluxe motorcoach transfers between hotels/airports, 7 nights lodging, superior rooms, full European breakfast daily, 4-course dinner nightly, wine and cheese welcome, 5 of 7-day lift ticket, portorage, baggage tags and travel packets.

BASIC PACKAGE PRICE: \$2,765 double occupancy; single supplement \$325;

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between departure airport & destination airport. **Land-only - deduct \$600. Non-skiers deduct \$330; Seniors deduct \$45; 6-day lift ticket add \$30, Senior 6-day deduct \$20; add balcony \$100;**

PAYMENT SCHEDULE

- \$775 initial deposit with application
- \$775 second installment by **August 11, 2020**
- \$775 third installment by **October 6, 2020**
- Final payment, balance plus any extras requested by **December 1, 2020**

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due.

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, must be printed, legible, and must match your PASSPORT. If there is a name discrepancy, fee is \$100. To transfer ticket to a substitute passenger fee is \$250.

DEVIATIONS FROM ITINERARY: Those traveling from other gateways will only need to pay the difference in the airfare from their departure city.

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to October 31, 2020 - \$140**
- **Cancellation from November 1, 2020 through November 25, 2020 - \$340**
- **Cancellation from November 26 through December 25, 2020 - \$640**
- **NO REFUND for cancellation ON OR AFTER December 26, 2020**

TRAVEL INSURANCE IS HIGHLY RECOMMENDED for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, most insurance companies require you to obtain insurance within two weeks from the date you made your trip deposit. Group coverage is also available through the tour operator for this trip where age is not a factor in price.

DAMAGES: Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless deposit is made with a signed trip application acknowledging the trip terms
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand in Loco Parentis Form*
