

**SUSQUEHANNA SKI & SNOWBOARD CLUB
BIG SKY 2021 TRIP TERMS**

All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes air and ground transportation from Harrisburg to Big Sky Resort in Montana, 7 nights lodging at the Huntley Lodge with daily breakfast, welcome reception, 5-day lift ticket, and tips. Airline checked baggage fees are NOT included in the basic package price.

Basic package prices: \$ 2896 single occupancy; \$2110 double occupancy; \$1941 triple occupancy; \$1842 quad occupancy. Add \$99 to the package if you prefer a 6-day lift ticket. Senior skiers 70+ may deduct \$34 from the 5-day ticket. Non-skiers or ICON passholders may deduct \$376 for the 5-day ticket.

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between BWI and Bozeman, Montana. **Land-only prices:** \$2545 single occupancy; \$1759 double occupancy; \$1590 triple occupancy; \$1491 quad occupancy.

PAYMENT SCHEDULE

1. \$700 initial deposit with application
2. \$700 second installment by October 8, 2020
3. Balance plus any extras requested/less eligible discounts by November 7, 2020

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, **must be legible, and must match your government-issued photo ID that is in compliance with the 'REAL ID Act of 2005'**. If the information provided on participant application is incorrect, the participant is responsible for the airline name change fee. The minimum airline name change fee is \$250.

SHIFT FEES: If you cancel after ticketing and find your own replacement, there is a deviation and reticketing \$275 fee.

DEVIATIONS FROM ITINERARY: \$25 fee per change + Airline Charges of \$250

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- **Cancellation prior to 9/30/20 - \$35**
- Cancellation from 10/1/20 through 11/30/20 – up to \$1771 fee
- NO REFUND for cancellation ON OR AFTER 12/1/20

TRAVEL INSURANCE IS HIGHLY RECOMMENDED for all trip participants, especially in light of unforeseen events. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition most insurance companies require you to obtain insurance within two weeks from the date you made your trip deposit (this may vary among insurance companies).

DAMAGES: Individuals are responsible for any damages that participants may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless trip deposit is made.
- Signed Big Sky Trip application acknowledges these trip terms.
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
