

**SUSQUEHANNA SKI & SNOWBOARD CLUB  
WHISTLER BLACKCOMB TRIP TERMS**

*All prices and fees listed are per person.*

**BASIC PACKAGE & PACKAGE PRICES:** Basic package includes Roundtrip bus from Harrisburg to Dulles. Roundtrip air from Dulles to Vancouver, ground transfer from Vancouver to Whistler, 7 nights lodging, 5 of 6 day lift ticket, group portage, and a welcome reception. Airline checked baggage fees are NOT included in the basic package price. Please note, you are required to have a valid passport and remember that if your passport does not have more than 6 months of validity when you travel, you may be turned away at the airport.

**Basic package prices:** \$2,935.00 single occupancy; \$2,073.00 double occupancy. A 6<sup>th</sup> day lift ticket is available for an additional \$98.00. Senior (65 plus) lift ticket, deduct \$22.00; senior 6<sup>th</sup> day lift ticket, add \$48.00. Non-skiers deduct \$409.

**LAND-ONLY PACKAGE & PACKAGE PRICES:** Land-only package includes all elements of basic package less the roundtrip airfare between Dulles & Vancouver. Ground transportation is NOT guaranteed if individuals arrive at different times after the main group (scheduled or actual) **Land-only prices:** \$2,458.00 single occupancy; \$1,596.00 double occupancy.

**PAYMENT SCHEDULE**

- \$660.00 initial deposit with application
- \$700.00 second installment by September 5, 2018
- Final payment, balance plus any extras requested by November 6, 2018

**LATE PAYMENT FEE:** \$20.00 on all payments seven (7) calendar days past due

**NAME CHANGE FEES:** The name(s) printed on your trip application will be used for airline ticketing, must be legible, and must match your government-issued passport. Please include a copy of your passport with the application. If there is a discrepancy, minimum name change fee is \$200.00.

**SHIFT FEES:** If you cancel after ticketing and find your own replacement, name change fees as stated above will also apply.

**DEVIATIONS FROM ITINERARY:** Individual deviations from the group's itinerary must be requested by email and are considered waitlisted pending airline availability. Deviations will require a \$25.00 surcharge per person. Deviations after ticketing will be assessed at \$200.00 change fee subject to availability.

**CANCELLATIONS** will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. **Cancellation fees will apply if replacement is not found.** Cancellation fees include:

- **Cancellation prior to September 5, 2018 \$40.00 fee**
- Cancellation from September 5, 2018 through October 5, 2018 - \$100.00 fee
- Cancellation from October 6, 2018 through November 6, 2018 - \$300.00 fee
- NO REFUND for cancellation ON OR AFTER November 7, 2018.

**TRAVEL INSURANCE** is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, you should contact your trip leader prior to submitting your initial deposit and application to assure coverage.

**DAMAGES:** Individuals are responsible for any damages that they may cause to lodgings and resort facilities, equipment and provided transportation

**OTHER REQUIREMENTS:**

- Reservations cannot be accepted unless deposit is made and trip application and terms agreements are signed
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
