January 20-27, 2024

All prices and fees listed are per person.

BASIC PACKAGE & PACKAGE PRICES: Basic package includes Roundtrip bus to Baltimore (BWI) airport, Roundtrip airfare on United Airlines (Baltimore-Denver-Kalispell), Roundtrip transfers Kalispell to Whitefish, seven nights lodging @ Kandahar Lodge, baggage handling, welcome party, daily breakfast, five of eight-day interchangeable lift tickets valid at Whitefish. Airline checked baggage fees are NOT included in the basic package price. **Basic package prices:** \$2,583 single occupancy; \$2,040 double occupancy; \$1,907 triple occupancy; \$1,846 quad occupancy. Discounted lift ticket prices are available: Deduct \$365.00 for non-skiers. Add \$87 for Adult 6th day. Deduct \$50.00 for Seniors 65-69 with a five day lift ticket, add \$74 to upgrade to six day lift ticket. Deduct \$230.00 for Super Seniors 70+ with a five day lift ticket, add \$30 to upgrade to six day lift ticket.

LAND-ONLY PACKAGE & PACKAGE PRICES: Land-only package includes all elements of basic package less the roundtrip airfare between Baltimore-Denver-Kalispell. **Land-only prices:** \$1,888 single occupancy; \$1,345 double occupancy; \$1,212 triple occupancy; \$1,151 quad occupancy.

PAYMENT SCHEDULE

- \$700 initial deposit with application
- \$700 second installment by October 3, 2023
- Final payment, balance plus any extras requested by November 07, 2023

LATE PAYMENT FEE: \$20.00 on all payments seven (7) days past due

NAME CHANGE FEES: The name(s) printed on your trip application will be used for airline ticketing, **must be legible, and must match your government-issued photo ID that is in compliance with the 'REAL ID Act of 2005'**. If the information provided on participant application is incorrect, the participant is responsible for the airline name change fee. The minimum airline name change fee is \$200 for **Name change** after December 11, 2023 but prior to January 12, 2024. No name changes after January 12, 2024.

SHIFT FEES: If you cancel after ticketing and find your own replacement, \$100 to \$150 fee. Name change fees as stated above will also apply.

DEVIATIONS FROM ITINERARY: \$50 fee per change + Airline Charges

CANCELLATIONS will become valid upon confirmed receipt of a written notice to the trip leader from the participant, or being removed by the trip leader for non-payment. To avoid cancellation fees, it is the trip participant's responsibility to find a replacement. Cancellation fees will apply if replacement is not found. Cancellation fees include:

- Cancellation prior to 09/05/23 – up to \$105 fee
- **Cancellation from 9/6/23 through 10/10/2023 -up to \$150**
- Cancellation from 10/11/2023 through 12/09/2023 -up to \$250 fee
- NO REFUND for cancellation ON OR AFTER December 10, 2023

TRAVEL INSURANCE is recommended for all trip participants. It is the responsibility of each participant to secure their own insurance based on their individual needs. If you have a pre-existing condition, the participant should contact your trip leader prior to submitting the initial deposit and application to assure coverage. Due to recent events **travel insurance is highly recommended.**

DAMAGES: Individuals are responsible for any damages that participants may cause to lodgings and resort facilities, equipment and provided transportation

OTHER REQUIREMENTS:

- Reservations cannot be accepted unless trip deposit is made.
- Signed Whitefish, Montana Trip application acknowledges these trip terms.
- Applicant must be current SSC members or must have applied for membership
- If you are traveling with a child or children other than your own, please contact trip leader for *Power of Attorney Form* and *Agreement to Stand In Loco Parentis Form*
